\*The purpose of this meeting is to allow Board Members to participate in the Community Improvement Committee meeting. 'After significant analysis and community input during 2011 and 2012, an Alternatives Analysis (AA) Report recommended that four alternatives be further studied through the preparation of an Environmental Impact Statement/ Environmental Impact Report (EIS/EIR). These include two required alternatives – No Build and Transportation System Management (TSM) – and two build alternatives – [along Van Nuys Boulevard] Light Rail Transit (LRT) and Bus Rapid Transit (BRT).

EIS/EIR Scoping – March 1-May 6, 2013:

Environmental review begins with a "scoping period" to allow for input on the issues that should be addressed in the EIS/ EIR.

Scoping Report – Summer 2013 (est.):

At the conclusion of the scoping period, Metro prepares a Scoping Report summarizing the input received and identifying any changes that result to the scope of the Draft EIS/EIR.'

Relying on public participation, Arleta Neighborhood Council's **success** reaches far beyond the Board.

Los Angeles Department of Transportation

Arleta Neighborhood Council Board took action on May 28, 2013 to transmit this request to the Los Angeles Department of Transportation study and install a traffic signal and crosswalk at the intersection of Arleta Avenue and Filmore Street adjacent to the new park project known as Devonshire/Arleta Park - in order to provide safety to the greater numbers of parents and children frequenting the new recreation and park facility. Several abutting neighbors have raised valid concerns for the added pedestrian and vehicular traffic and potential adverse safety impacts.

In addition, the Arleta Neighborhood Council Board is requesting here the Los Angeles Department of Transportation study and install a traffic signal, crosswalk, and street lighting at the intersection of Woodman Avenue and Montegue Street next to Valor Academy Charter School.
